#### C. Review and Vote on January Minutes

March 25, 2019, meeting minutes unanimously approved.

#### **D.** Committee Reports

#### 1. Treasurer- Ellen N

Financial statement FYTD Mar 18, 2019, was accepted (see page 4).

Presented 2019-20 proposed budget (see page 5). Cost of insurance is not yet known.

**MOTION**: Ellen moved that the budget be approved; 2<sup>nd</sup> by Reta. **PASSED** unanimously.

#### 2. Trip- Art

No trips planned as no classes have proposed trips so far. Also, insurance cost not yet determined. New advertising posters are now ready (see page 6).

#### 3. Membership-Rollie

Current membership count is 123, which includes 9 pro-rated and 9 gift memberships. No change from last year in proposed budget. Annual picnic will be Aug 9, 2019, but Cullaby Lake has not yet been reserved. No lunch bunch info.

#### 4. Curriculum - Reta

161 people attended Chinese in Astoria event. Current class attendance has improved a bit.

Thirteen membership gift certificates proposed this year. **MOTION**: Reta asked for Board approval; 2<sup>nd</sup> by Ellen. **PASSED** unanimously. Discussion of people to be recognized in memoriam at annual meeting. Mention was made of a possible summer course.

#### 5. CCC Liaison - Leah

CCC will hold a writing class in Seaside by a local author. Will/can ENCORE advertise/promote this class. Ellen mentioned Board restrictions prohibiting web-based ads. Reta suggested changing Relationship Agreement to allow CCC classes to be included in ENCORE website promotions.

To delay presentation of these Bylaws changes until sometime after the June annual meeting. **PASSED**: unanimously.

Revised RA has been submitted to CCC officer for review and consideration. Seeking clarification of CCC mailing address.

#### 4. Update on 501(c)(3) filing - Ellen

Application has been filed with the IRS. Expect 1 month or more for approval.
