C. Review and Vote on January Minutes

1. Treasurer- Ellen N

2. Trip- Art

3. Membership-Rollie

Current count is 116, which includes 21 new members. Finalizing plans for Chinese in Astoria. Next Lunch Bunch will be at Jalisco in Astoria. Perhaps development of a poster to advertise ENCORE targeting news members. Some consideration of changing the meaning of ENCORE acronym.

4. Curriculum - Reta

Spring term begins April 2 thru May 24th with no classes on Mondays. Philosophy class Friday

mornings. Fewer classes scheduled. Winter term attendance is lower than expected. Very difficult to fill south county classes.

E. Unfinished Business

1. Donation of ENCORE books in storage - Mike

Astoria Library has agreed to accept donation of books that we have stored at CCC.

MOTION: To approve the donation of all 63 books currently in storage at CCC to the Astoria Library with the understanding that any books that cannot be used by them may be transferred to the Friends of the Library.

PASSED: Unanimously.

2. Update on 2018-19 Signature Event - Erhard

Issue was revisited due to 3 Board members unavailable during vote January 28th. Ellen recommended we file and declare our fiscal year beginning in January instead of July. **MOTION** (Frank): To file IRS 501(c)(3) application with a January fiscal start date. Ellen seconded.

MOTION (Rollie): That Frank withdraw his motion. Mike seconded.

PASSED: Unanimously.

MOTION WITHDRAWN (Frank).

Note: our Bylaws, Article IV, declare our fiscal year shall be July 1 to June 30.

Quantification of Services

A proposal from the Curriculum Committee to the Board of Directors

Organizing Trips and Signature Programs do take lots of time. Giving people credit for these the way we reward teachers who teach at least six credits may help us in attracting persons who can render these kinds of service to ENCORE.

We need to incentivize such programs as well as field trips. The Curriculum Committee, with the assistance of the Trip Committee, proposes to our Board the following weighted guidelines:

Field Trips:

- A) Any person who teaches at least one two-hour session in conjunction with at least a oneovernight field trip should be rewarded with a full membership for the following academic year.
- B) Any person who organizes at least three one-day field trips per academic year should also be rewarded with a full membership for the following academic year.

All field trips should have a minimum number 12 of participants.

Signature Events:

Any person who organizes a signature event that is open to the public should be rewarded the same way we give credit to persons who organize field trips.

Pop-up Classes:

Any person who organizes a pop-up class with at least six sessions, of which he/she teaches at least one, should be rewarded the same way the organizers of field trips and signature events are rewarded.

Co-organizers:

In cases where the principle organizer of any of the above activities is substantially assisted by a second person, the two persons should share the credit by percentage.

It is the responsibility of the chairpersons of the Curriculum Committee and, when applicable, the Trip Committee to administer the above mentioned categories of rewards.
