C. Review and Vote on April Minutes

April 22, 2019, draft meeting minutes unanimously approved without changes.

D. Committee Reports

1. Treasurer – Ellen

The YTD - 5/26/19 – financial report was submitted and accepted by the Board (see page 4).

2. Trip- Art

Committee is considering merging Oktoberfest and Oregon Gardens as a class. Pending a resolution of insurance concerns, trip planning is pending.

3. Membership- Rollie

There was no meeting in May. Plans are firming up for taking over membership responsibilities with a new process. Hoping to arrange a tour of the CCC library following June annual meeting. Rental of space at Cullaby Lake for Aug 9th picnic is confirmed.

4. Curriculum - Reta

Fall term will have some new instructors and new classes. Thirteen complimentary membership awards given for 2019/20 to instructors for teaching six hours or more during the past year.

5. CCC Liaison - Leah

CCC 2019 graduation is next week and summer classes begin. Rollie has been meeting with Leah to shift responsibility of membership records management.

6. Nominating – Frank

Slate of nominees for annual meeting election is: Dave Zunkel – President; Tom Shaeffer – Vice President; Ellen Norris – Treasurer; Jean McGonigle - Secretary.

E. Unfinished Business

1. Insurance follow-up - Mike

Three bids were received via our broker. A cost comparison chart was presented with some discussion about various coverages and limits. One amended quote not yet received. Recommended that D&O coverage be purchased to be effective NLT July 1st.

2. Relationship Agreement with CCC - Leah

RA has been signed by CCC with only two minor changes that were acceptable to ENCORE. **MOTION**: Frank moved that we accept and sign the RA; Art 2nd. **APPROVED** unanimously (See Page 5). Note – waiting for copy of signed agreement.

3. Signature Event Update – Dave

Nothing other than event will be held May 2020.

4. Level of Support for Conference on Extraordinary Living - Leah

Continued discussion of ENCORE participation and contribution of event to be held Sep 7, 2019. **MOTION**: Frank moved that ENCORE support COEL again this year and contribute \$500; Art 2nd. **PASSED** unanimously.

5. Review of proposed Bylaws changes - Dave

Dave discussed a number of issues regarding the construct of the recommended set of Bylaws by our legal counsel. Because of the change in the number of elements that are significantly different from our current Bylaws, Dave will seek revisions to reduce the scope of the proposed changes.

F. New Business

1. Media liaison position again open - Dave

A Job Description is being written to better define the position requirements.

2. Inventory issues - Mike

Further description of items in storage was presented with a recommendation that some materials be relocated to a storage area within ASC. Some available space has been identified by Larry.

Mike recommended that the Board develop a complete list of items and ensure that Board members are fully aware of all items that belong to ENCORE.

3. Working with Warrenton Senior Center - Dave

Dave is working with Jerry O'Neill to determine what level of cooperation can be agreed upon. Some Board members recalled issues related to prior use of their facilities.
